- Assist in external airworthiness authority / customer audits.
- Follow-up with process owners to ensure prompt corrective actions are duly completed.
- Monitor open audit findings, including monitoring of corrective action plans.
- Conduct internal briefing / training for certifying staff and technicians as necessary.
- Assist in maintaining the approved suppliers list.
- Monitor and process Company Authorization's renewal and applications.
- Maintain quality documents (e.g. QA Manuals) and quality management system.
